The primary mission of the International Society for the Prevention of Child Abuse and Neglect (ISPCAN) is the prevention of all forms of child abuse, neglect and exploitation worldwide. The organization educates and trains child protection professionals so that they have the expertise to help abused, neglected and at-risk children around the world. The organization is also committed to

Child Abuse and Neglect Prevention Programs: The organization's Congress and Conference Program included expenses for its Regional Conferences on Child Abuse and Neglect, which were held in Dublin, Ireland in September 2013 and in Vina del Mar, Chile in October 2013. The conference in Ireland was attended by almost 700 child abuse professionals from 59 countries. The conference in Chile was attended by almost 750 child abuse professionals from 27 countries. This program also included expenses for advance planning of its international congress to be held in Nagoya, Japan in September 2014; regional conferences to be held in Mexico, Romania and Malaysia in 2015; and an international congress to be held in Calgary, Canada in 2016. Approximately 4,200 child protection professionals are expected to attend the 2014, 2015 and 2016 congresses and conferences. The objectives of all congresses and conferences are to offer education, present innovative approaches, share evidence-based best practices, and provide networking opportunities to child protection professionals in multiple disciplines throughout the world in order to improve their ability to diagnose, treat and prevent child abuse and neglect. The organization received donated legal services valued at \$46,613 during 2013 to assist the Congress and Conference Program.

4b (Code:) (Expenses \$ 82,410 including grants of \$ 0) (Revenue \$ 151,178)

Child Abuse and Neglect Prevention Programs: The goal of the organization's Membership Services Program is to facilitate the exchange of information and education of professionals working to prevent and treat child abuse and neglect worldwide. The organization had 1,226 members in 100 countries around the world. The organization received donated legal services valued at \$15,950 to assist the Membership Services Program.

Child Abuse and Neglect Prevention Programs: The organization's Research and Publications Program included the cost of "Child Abuse & Neglect: The International Journal" (the Journal), a monthly peer-reviewed publication provided to the organization's members; 15,810 issues of the Journal were published in 2013. Members also have on-line access to all previous issues of the Journal. "LINK" newsletters were also written and provided on a triannual basis to the organization's members via email and posting on the organization's website; approximately 200 copies of the "LINK" were printed for distribution at the organization's Regional Conferences on Child Abuse and Neglect, which were held in September 2013 in Dublin, Ireland and in October 2013 in Vina del Mar, Chile. In addition, the LINK newsletter, in 6 languages, is available on ISPCAN's website. Preliminary work, including preparing surveys and analyzing responses, on the eleventh edition of "World Perspectives on Child Abuse" was done in 2013; the book will be printed and issued in 2014. Attendees of the organization's International Congress on Child Abuse and Neglect, to be held in September 2014 in Nagoya, Japan, will be provided with a complimentary copy of the "World Perspectives". Elections for upcoming vacancies to the Executive Council are held biennially; the next election will occur in 2014. Candidates for the Executive Council must be current paid members in good standing and have been paid members in good standing for at least the previous twelve months. Candidates must be nominated by at least two other current paid members in good standing of the organization.

Form 990, Part VI, Section A, Line 7b - ISPCAN's constitution may be amended, altered or repealed by a two-thirds majority vote of the members present and permitted to vote (that is, they must be a member in good standing) at any general meeting of the organization.

Form 990, Part VI, Section B, Line 11b - The organization's Form 990 is reviewed by the Executive Council, the organization's governing body, prior to filing the Form 990 with the Internal Revenue Service (IRS). The draft of the Form 990 is sent to the Executive Council via email. The Executive Council includes the President, President Elect, Past President, Treasurer, Secretary, and the Finance and Audit Committee, along with all other elected councilors. The draft of the Form 990 is also reviewed by the organization's Executive Director and Legal Advisor prior to filing the form with the IRS. Any questions or comments that the Executive Council, Executive Director, or Legal Advisor have are addressed prior to filing the Form 990 with the IRS.

Form 990, Part VI, Section B, Line 12c - The International Society for the Prevention of Child Abuse and Neglect (ISPCAN) monitors and enforces compliance with its conflict of interest policy by requiring the members of its Executive Council, which is ISPCAN's governing body, to review and sign its conflict of interest policy on an annual basis. In addition, the conflict of interest policy and its importance are reviewed and explained at every Executive Council meeting and to all new councilors when they are elected. The Executive Director also signs a conflict of interest statement on an annual basis. The conflict of interest policy is also included in the organization's personnel policies, which every employee receives a copy of and is required to read. All new employees sign a letter signifying that the employee has received and read the personnel policies, including the conflict of interest statement, and agrees to abide by all policies.

Form 990, Part VI, Section B, Line 15 - The Executive Director's initial compensation, effective December 31, 2010, was recommended by the organization's Personnel Committee, President and Treasurer; was approved by the Executive Council, the organization's governing body; and was agreed to in a written employment agreement with the Executive Director. The amount of initial compensation was determined after review of comparable salaries and benefits of executive directors of similar nonprofit organizations and after review of the position's duties and responsibilities. Subsequently, in accordance with the Executive Director's written employment agreement, the Executive Director shall receive an annual cost of living increase indexed to the U.S. All Urban Consumers Price Index. In 2013, the Executive Director did not receive a cost of living increase. Per the written employment agreement, the Executive Director is also eligible for an annual salary review and salary increase based on the annual performance evaluation performed by the Personnel Committee and within the constraints of the organization's financial budget. This potential salary increase is capped at 7% of the base salary. In 2013, the Executive Director received partial reimbursement of classes towards a Master's degree in Nonprofit Management in lieu of the approved 5% salary increase. The amount of reimbursement was less than the 5% salary increase that was approved by the Executive Council. Reimbursement was made after satisfactory completion of each class. The Executive Director was the only key employee in 2013.
