Our primary mission is the prevention of all forms of child abuse, neglect and exploitation worldwide. We educate and train child protection professionals so that they have the expertise to help abused, neglected and at-risk children around the world. We are also committed to increasing public awareness of all forms of violence against children, developing activities to prevent such violence, and promoting the rights of children in all regions of the world.

Child Abuse and Neglect Prevention Programs: The organization's Congress and Conference Program included expenses for its International Congress on Child Abuse and Neglect, which was held in Istanbul, Turkey in September 2012 and was attended by 821 child abuse professionals. This program also included expenses for advance planning of its international congress to be held in Nagoya, Japan in September 2014; regional conferences on child abuse and neglect to be held in Dublin, Ireland in September 2013 and Vina del Mar, Chile in October 2013; and the Denver Thinking Space to be held in Aurora, Colorado in March 2013. Approximately 2,100 child protection professionals are expected to attend the 2013 and 2014 conferences and congress. The objectives of all congresses and conferences are to offer education, present innovative approaches, share evidence-based best practices, and provide networking opportunities to child protection professionals in multiple disciplines throughout the world in order to improve their ability to diagnose, treat and prevent child abuse and neglect. The organization received donated legal services valued at \$42,625 during 2012 to assist the Congress and Conference Program.

4b (Code:) (Expenses \$ 91,676 including grants of \$ 18,000) (Revenue \$ 0)

Child Abuse and Neglect Prevention Programs: The organization's Training, Consultation, Education and Resources Program covers several projects. One project is the development and support of regional resource centers in Argentina and South Africa, which provide materials and resources to child protection professionals. ISPCAN also provides technical assistance and support to the Working Group on Child Maltreatment Data Collection, including support of development of related publications, research and coordination of technical activities. ISPCAN also reviewed and updated several of its training materials and curricula, which are available on its website in 6 languages. The objective of the Training, Consultation, Education and Resources Program is to provide consultation services and technical assistance to help countries and child protection organizations establish or improve their child protection systems, assist with assessment of compliance with the United Nations Convention on the Rights of the Child, develop child abuse data collection systems, conduct research on child maltreatment, assist countries to develop child protection policies, and assist in the establishment of monitoring and evaluation programs for child protection services. The organization received donated legal services valued at \$10,038 during 2012 to assist the Training, Consultation, Education and Resources Program.

Child Abuse and Neglect Prevention Programs: The organization's Research and Publications Program included the cost of "Child Abuse & Neglect: The International Journal" (the Journal), a monthly peer-reviewed publication provided to the organization's members; approximately 13,300 issues of the Journal were published in 2012. "LINK" newsletters were also written and provided on a triannual basis to the organization's members via email and posting on the organization's website; 200 copies of the "LINK" were printed for distribution at the organization's International Congress on Child Abuse and Neglect, which was held in September 2012 in Istanbul, Turkey. The tenth edition of "World Perspectives on Child Abuse" was written and published; 800 copies were printed. Attendees of the organization's international congress on child abuse, held in September 2012 in Istanbul, Turkey, were provided with a complimentary copy of the "World Perspectives". The organization's may purchase the "World Perspectives" at a discounted price. The executive summary of the "World Perspectives" was translated into Arabic, Chinese, French, Russian and Spanish; all six languages, including English, of the executive summary were available on the organization's (Continued on Schedule O, Statement 3)

Schedule F, Part I, Line 2 - The International Society for the Prevention of Child Abuse and Neglect (ISPCAN) provides assistance to various child protection and child abuse prevention organizations outside the United States in order to fulfill its mission of protecting children around the world from abuse and neglect. This assistance is for training and education in the areas of child abuse prevention and treatment, capacity building for child abuse prevention programs, and development of training and resource materials. The organizations that ISPCAN works with are well-known and well-respected nonprofit organizations specializing in the prevention and treatment of child abuse and neglect. These organizations are researched by ISPCAN prior to beginning the process of program development within that country. Some of the requirements for these organizations are open membership, national or regional scope of projects and work, multidisciplinary focus, at least two years as a registered nonprofit organization in their country, a provision for training and education of child protection professionals in their normal activities, an organizational constitution, an elected board of directors, and letters of recommendation from well-known and respected organizations or individuals in the field of child protection. Before assistance is provided to an organization, ISPCAN and the organization discuss the funding available from ISPCAN, other sources of funding available to the organization, and the goals and outcomes to be achieved. The organization then provides a proposal, which includes a budget, specific objectives, measurable results, and details of the training and other projects that the organization will provide. After the specific trainings, other work, and budget are agreed upon, the funding assistance is provided. Upon completion of the specified trainings, workshops or other projects, the organization provides documentation to ISPCAN, which includes budget versus actual expense comparisons, copies of payments made by the organization, and a narrative report that details the trainings and workshops that occurred and specific outcomes achieved. In addition, ISPCAN also has regional coordinators who liaise between ISPCAN and the nonprofit organizations. The regional coordinators and ISPCAN Councilors attend many of the trainings and other events to monitor the quality of the trainings and workshops and ensure that the goals of the program are being met.

In 2012, the Executive Director did not receive a cost of living increase. Per the written employment agreement, the Executive Director is also eligible for an annual salary review and salary increase based on the annual performance evaluation conducted by the Personnel Committee and within the constraints of the organization's financial budget. This potential salary increase is capped at 7% of the base salary. The Executive Director did not receive a salary increase in 2012.

Elections for upcoming vacancies to the Executive Council are held biennially. Candidates for the Executive Council must be current paid members in good standing and have been members for at least the previous twelve months; they must be nominated by at least two other current paid members in good standing of the organization.

Form 990, Part VI, Section A, Line 7b - ISPCAN's constitution may be amended, altered or repealed by a two-thirds majority vote of the members present and permitted to vote (that is, they must be a member in good standing) at any general meeting of the organization.

Form 990, Part VI, Section B, Line 11b - The organization's Form 990 is reviewed by the Executive Council, the organization's governing body, prior to filing the Form 990 with the Internal Revenue Service (IRS). The draft of the Form 990 is sent to the Executive Council via email. The Executive Council includes the President, President Elect, Past President, Treasurer, Secretary, and Finance and Audit Committee, along with all other elected councilors. The draft of the Form 990 is also reviewed by the organization's Executive Director and Legal Advisor prior to filing the form with the IRS. Any questions or comments that the Executive Council, Executive Director or Legal Advisor have are addressed prior to filing the Form 990 with the IRS.

Form 990, Part VI, Section B, Line 12c - The International Society for the Prevention of Child Abuse and Neglect (ISPCAN) monitors and enforces compliance with its conflict of interest policy by requiring the members of its Executive Council, which is ISPCAN's governing body, to review and sign its conflict of interest policy on an annual basis. In addition, the conflict of interest policy and its importance are reviewed and explained at every Executive Council meeting and to all new councilors when they are elected. The Executive Director also signs a conflict of interest statement on an annual basis. A conflict of interest policy is also included in the organization's personnel policies, which every employee receives a copy of and is required to read; all employees sign a letter signifying that the employee has received and read the personnel policies, including the conflict of interest policy, and agrees to abide by all policies.

Form 990, Part VI, Section B, Line 15 - The Executive Director's initial compensation, effective December 31, 2010, was recommended by the organization's Personnel Committee, President and Treasurer and was approved by the Executive Council, the organization's governing body, and was agreed to in a written employment agreement with the Executive Director. The amount of initial compensation was determined after review of comparable salaries and benefits of executive directors of similar nonprofit organizations and after review of the position's duties and responsibilities. Subsequently, in accordance with the Executive Director's written employment agreement, the Executive Director shall receive an annual cost of living increase indexed to the U.S. All Urban Consumers Price Index. In 2012, the Executive Director did not receive a cost of living increase. Per the written employment agreement, the Executive Director is also eligible for an annual salary review and salary increase based on the annual performance evaluation performed by the Personnel Committee and within the constraints of the organization's financial budget. This potential salary increase is capped at 7% of the base salary. In 2012, the Executive Director did not receive a salary increase. The Executive Director was the only key employee in 2012.
