In addition, she works with victims of suspected physical/sexual abuse, and sex trafficking at the Stephanie Blank Center for Safe and Healthy Children at Children's Healthcare of Atlanta. She co-chairs the Human Trafficking committee for the Ray Helfer Society and is a past president of APSAC. She trains nationally and internationally, working with child-serving professionals to prevent, identify and intervene in cases of suspected abuse and exploitation.
